# Message from the President

## MICHAEL ORR

Dear Sitnasuak Shareholders,

The next few months will be exciting ones for our Corporation. We are currently planning our 2016 Annual Meeting of Shareholders, and we're preparing to announce our 2015 financial results in the upcoming annual report to shareholders.

I look forward to sharing our success with you in informational sessions to be held in April and early May in both Anchorage and Nome. We hope to reach as many shareholders as possible prior to the Annual Meeting to address concerns and provide accurate and factual information about our Corporation's financial performance and election processes.

I also want to take a moment to inform you of a settlement that we reached with the State of Alaska Division of Banking & Securities. This settlement was a product of an appeal Sitnasuak pursued with the Office of Administrative

Hearings. The settlement required Sitnasuak to pay a fine of \$1,000 for two violations – one involving the 2014 proxy statement and one involving the 2015 proxy statement. In those two proxy statements, Sitnasuak failed to disclose the prior employment history of a candidate for the Board of Directors, and then for a continuing director.

The investigation and associated settlement was a result of another board member filing a complaint against Sitnasuak with the Division of Banking & Securities for these non-disclosures. That director did not communicate with the Corporation to resolve the non-disclosure issue but requested that the Division of Banking & Securities investigate Sitnasuak. The resulting process was costly for the Corporation, and we have revised our processes to avoid these oversights in the future. The responsibility for the accuracy of Sitnasuak proxy statements is that of the



President, and I assure you that I take this responsibility very seriously.

The management team at Sitnasuak is pleased to be of service to all shareholders, and we are committed to ensuring that the Corporation's processes run smoothly and accurately going forward.

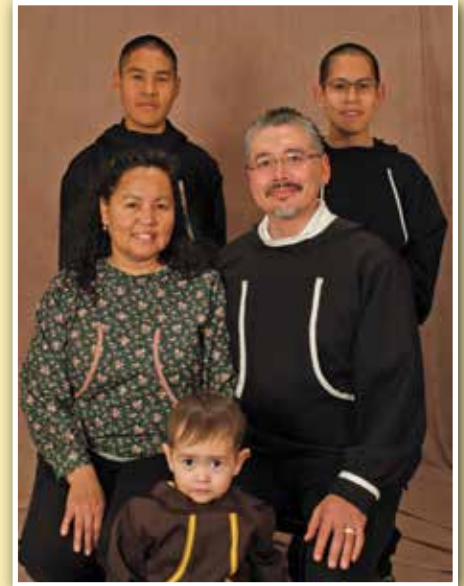

We will cover the current voting process, listen to shareholder concerns, and give shareholders more opportunities to share ideas and to make recommendations,” said Ukallaysaaq.

Ukallaysaaq was born and raised in Nome. His parents are LaVonne and the late Franklin Okleasik, Sr. His wife is Igluquq Dianne Okleasik, originally from Kotzebue, and his son is Talugnaqtuaq and step-sons are Ivik and Qaulluq Henry.

Ukallaysaaq is the principal consultant and owner of Northwest Planning and Grants Development – a business he started in 1998. He graduated with honors from California Lutheran University with a Bachelor of Science degree in Business Administration and has been working to complete a master’s in rural development through the University of Alaska.

His career experience includes: planning director for the Northwest Arctic Borough; executive director of the Native Village of Kotzebue; senior trainer for Native American Management Services – Alaska Training Center; vice-president of Kawerak Inc.’s Community Service Division; project director of Central Council of Tlingit and Haida’s Vocational Training and Resource Center; and business manager of the Northwest Campus – UAF.

Past work has included organizing joint planning commission meetings between the Northwest Arctic and North Slope Boroughs, updating village comprehensive plans, training in grant writing, strategic planning with organizations, community wellness campaigns and facilitation of the 2015 Norton Sound Education Summit.

# Sitnasuak Financial Services, LLC

## BUSINESS LINE UPDATE

Sitnasuak's Financial Services, LLC is composed of the two businesses – Fidelity Title Agency of Alaska, LLC in Anchorage and Mat-Su Title Agency, LLC in Wasilla. Both companies have been part of the Sitnasuak family since December 2012 and have strong reputations for exceptional service in providing title insurance for real estate transactions. The two companies derive a significant portion of their profits by performing title searches on properties that are being sold or refinanced. They also provide escrow services for similar transactions.

As properties are sold or re-financed, Alaska state law requires the buyers and/or sellers to hire title agencies to research the property's title history. This process will verify that the seller does indeed legally own all of the rights associated with the real property and confirm there are no third party liens outstanding. As the transaction progresses, the escrow function will collect all cash payments from applicable parties and disburse all funds per transaction documents on the day of closing. While escrow functions typically do not generate large profits, they are a tremendous source of new business for the more lucrative title function.

Since the acquisition of the two title companies, Sitnasuak Financial Services has posted business unit income in excess of \$2.2 million and \$2.4 million in the years 2013 and 2014 respectively. Financial Services just ended a phenomenally good year in 2015 and expect final business unit income to exceed a record high of \$2.8 million.
