### sitnasuak celebrates a milestone:

### **50TH ANNUAL MEETING**

Sitnasuak Native Corporation convened its 50th Annual Meeting of Shareholders in Nome, a milestone event that brought together shareholders, board members, management, and honored guests. The event was a celebration of the Corporation's rich history and its promising future. With an engaging agenda and numerous highlights, the meeting captured the essence of Sitnasuak's commitment to its shareholders and the broader community.

### Call to Order and Welcome

The meeting began promptly at 10:00 AM with a formal Call to Order, setting the tone for the day's proceedings. The Invocation by shareholder, Arlene Soxie and a Moment of Silence in Memoriam were provided to give thanks for all that the Corporation has accomplished and to remember all the shareholders we had lost over the year.

### **Warm Welcome and Introductions**

The SNC Chair extended a heartfelt welcome to all attendees, underscoring the significance of the 50th Annual Meeting. The Roll Call followed, with the Board of Directors being introduced, showcasing the dedicated individuals steering the corporation's growth and decisions. The Management Team, Staff, and Guests were also introduced, emphasizing the collective effort behind SNC.

# **Empowering Shareholders Through Information**

The Presentation of the Agenda set the stage for the day, ensuring all participants knew what to expect, followed by the presentation of the 49th Annual Meeting minutes which provided a chance to reflect on the progress made since the last gathering.

The Inspector of Elections reported a quorum of 45.1% of shares represented which provided a segue to Candidate Speeches. These speeches provided shareholders with the opportunity to hear from incumbents as well as new nominees running for the Board of Directors.













### **Cultural Celebration and Guest Speaker**

This year's lunch break was more than a meal—it was a showcase of traditional Native foods presented and served by youth volunteers from Nome Beltz High School's Arctic Indigenous Governance class. Following lunch, traditional songs and dance were performed by the Nome St. Lawrence Island group, highlighting the importance of cultural preservation.

Guest Speaker Carol Piscoya, introduced by her granddaughter Christine Piscoya, shared insights, and inspiration, contributing to the meeting's theme of connecting generations and celebrating diversity.

### **Honoring Commitment and Dedication**

A series of Recognitions acknowledged the contributions of past Board of Directors, staff, and employees. Their milestone service anniversaries were celebrated. underscoring their longevity and commitment to the Corporation. Additionally, A Military Recognition was presented by our guests from the Alaska National Guard, who recognized the commitment and selfless service of the men and women who have served in the Guard. safeguarding our homeland. and protecting our communities.

Wrapping up Recognitions, shareholders Arlene M. Soxie and Ralph Olanna, Jr. were both presented as the SNC 2023 Elders of the Year; being recognized for their contributions and dedication to our community and their commitment to upholding and sharing our Inupiaq values.

### **Reporting Progress and Future Visions**

CEO Charles E. Fagerstrom's Report on Operations and Lines of Business outlined the corporation's achievements and subsidiary updates from the previous year. # bonanza express undergoes

# STATION UPGRADES

Sitnasuak Native Corporation subsidiary Bonanza Fuel has successfully wrapped up an extensive 2-month renovation project at the Bonanza Express fueling station. This project, which temporarily closed the station, has ushered in a new era of enhanced service and convenience for all customers.

The renovation encompassed a range of significant improvements, all aimed at making the customer fueling experience smoother and more efficient. The most striking change is the addition of a modern and much larger overhead canopy. This canopy not only protects customers from the elements but also gives the station a fresh and sophisticated look.

Addressing customer feedback about accommodating longer vehicles and trailers, the gas station now boasts fuel dispensers which have been rotated approximately 30 degrees from their former position, ensuring that every vehicle, whether smaller or much longer vehicles with trailers, can navigate the parking lot and dispensers with ease. Another change is that each dispenser now offers both gasoline and diesel, so you can fill up with both products without having to move to another dispenser.

In prioritizing safety and environmental responsibility, the station replaced its existing underground diesel and gasoline storage tanks with new systems, guaranteeing secure fuel storage that adheres to the latest industry standards.

During the temporary closure, Bonanza Fuel leased land from the City of Nome to establish a temporary gasoline dispensing station. This station had dedicated attendants ready to assist customers with fueling and payment processing, ensuring that refueling needs were met, even during the renovation.

The construction project started several weeks late due to the delayed arrival of the spring freight barges still finished ahead of schedule, bringing Bonanza Express back online to full operation by the end of August. CEO Scot Henderson stated, "The renovations at Bonanza Express underscore our commitment to providing our customers with the best possible fueling experience. We are thrilled that our dedicated team and contractors, which included Bonanza Fuel staff, Prism Design and Construction, Q-Trucking, and Arcadis, could complete this project ahead of schedule, and we look forward to serving our customers with these improved facilities."

# ROUNDTABLE DISCUSSIONS FOR ALASKA

In recent weeks, Sitnasuak Native Corporation (SNC) participated in several roundtable discussions with key government officials, addressing critical topics affecting not only the corporation but all of Alaska. These conversations reflect SNC's commitment to fostering positive change and sustainable development across the state.

One of the prominent discussions involved SNC's participation in a roundtable with Small Business Administration (SBA) Administrator, Isabella Guzman, in Anchorage. The discussion centered around SBA activities that directly impact Alaska Native Corporations (ANCs). SNC took the opportunity to advocate for policies and initiatives that can empower Alaska's indigenous communities, promote economic growth, and provide much-needed support to ANCs in their mission to serve their shareholders.

Sustainable fisheries management has been a pressing concern in Alaska, given the state's dependence on its marine resources. SNC participated in a roundtable discussion, held in Soldotna on this subject with Alaska Congresswoman Mary Peltola and Alaska's Governor Mike Dunleavy. The corporation's involvement highlighted the importance of balancing economic interests with environmental stewardship, striving for sustainable fishing practices that benefit both the industry and the preservation of Alaska's pristine waters.

Another significant discussion involved infrastructure priorities in the Bering Strait region. SNC, alongside Bering Straits Native Corporation, Kawerak, Inc., Village of Solomon, Nome Eskimo Community, and others, had the privilege of engaging with Alaska's Economic Development Representative, Shirley Kelly, Assistant Secretary for Legislative and Intergovernmental Affairs, Susie Feliz, and Senior Advisor to President Biden on Infrastructure, Mitch Landrieu. This dialogue delved into essential infrastructure investments needed to bolster the region's connectivity, economic growth, and resilience to climate change.

# practicing responsible

### LAND STEWARDSHIP

Protecting SNC's lands and resources is a critical component of SNC's current Strategic Plan and Mission Statement. SNC's Land Department takes the management and protection of SNC lands very seriously. The Department manages approximately 232,174 surface acres in the Nome and Bering Strait region. The Department participates in negotiation and evaluation of campsite permits, homesite leases, access over SNC lands, different types of commercial use, and the implementation of corporate strategies related to the land. As you can imagine,

managing and protecting SNC lands can be a challenge.

SNC prioritizes striking a balance between protecting the land for future generations and sustainable commercial use to improve opportunities for our shareholders. Because SNC lands are privately-owned, shareholders and non-shareholders are required to obtain a permit for land access

and recreational and subsistence activities such as camping; hunting; road, trail, and off-road use; snow machine and dog races; and commercial and industrial activities such as mining exploration and operations; agriculture; land development; communications and construction projects; materials sales; and fisheries use.

Due to the remote nature of SNC lands, it is vulnerable to trespass, disturbance, and waste. Any non-authorized use on SNC lands is considered trespass and trespass can be caused by individuals and motor vehicle or equipment access.

Trespass may be prosecuted to the full extent of the law. Disturbance of the land occurs where there is a clearing of tundra, vegetation or soil, or land movement by motorized or other means. Waste occurs when there is an unreasonable, improper, harmful, or destructive use of the land such as pollution in any form, erosion, garbage, and trash.

Unfortunately, from time to time, the Land Department is informed that trespass, disturbance, and waste is occurring on SNC land by shareholders and non-shareholders. These are serious concerns presently and for our future generations of land users. The SNC Land Department cannot monitor all of our land and asks for assistance in mitigating these harmful practices.

If you observe trespass, disturbance, or waste, gather as much information as you safely can - including time, date, location and nature of the suspected activity and the person or vehicle involved - and report back to SNC by calling 907.387.1200 and asking for the Land Department. (For your safety, please do not attempt to confront anyone).

The future health and protection of SNC land is everyone's responsibility. SNC appreciates your cooperation and respect for our lands. Successful compliance with our land use policies will enable the continued use and enjoyment of SNC lands, now and into the future.





# ALASKA NATIVE CLAIMS SETTLEMENT ACT (ANCSA)

The Alaska Native Claims Settlement Act of 1971 (ANCSA) marked a new Congressional approach to Federal Indian policy. Unlike the reservation system, Congress sought to empower Alaska's Native people through ANCSA by giving them control over their own land and cash assets received through the settlement. In addition to resolving land claims, ANCSA mandated the creation of socially responsible, forprofit entities, which Congress termed "Alaska Native corporations," tasked with promoting the social, cultural, and economic advancement of their Alaska Native people and communities in perpetuity.





### SHAREHOLDER RECORDS

The Sitnasuak Native Corporation Shareholder Department maintains shareholder records that include stock information, personal data and addresses, as well as guardian and custodian information that may be associated with shares. The department is responsible for transferring shares and also records the amount of distributions shareholders receive. The department handles a large amount of information and maintains over 3,000 individual shareholder files which is an ongoing effort. The following information describes the types of records kept and their importance.

### Alaska Native Claims Settlement Act (ANCSA) Stock Wills

Taking care of a family means making sure they are looked after, even when a person is no longer around. A will is a legal document that states a person's wishes concerning the disposal of property, such as ANCSA stock, after death. Wills are an important part of life because they ensure a person's last wishes are known and followed. As years pass, a will should be updated to reflect life changes, such as a marriage, divorce, additional family members or death of an heir. A current stock will on file with Sitnasuak, or other Alaska Native Corporations, makes certain that stock is inherited by the people the shareholder chooses. In addition, SNC holds a quarterly monetary drawing for those who have updated Wills on file.

### **Gifting ANCSA Stock**

SNC shareholders have the option of gifting their ANCSA stock to their loved ones. Shareholders are only allowed to gift ANCSA stock to Shareholders are only allowed to gift ANCSA stock to (biological or adopted via the court or tribe) children, grandchildren, great-grandchildren, nephews, nieces, brothers and sisters. This person must be an Alaska Native,

or descendant of an Alaska Native. The person receiving the shares must submit proof of tribal enrollment in an Alaskan Native federally recognized tribe or submit proof of BIA enrollment (card or certificates are accepted).

### Maintaining Current Shareholder Records

It is important for shareholders to keep all information and records, including a will, current with SNC. For example, if a shareholder recently changed their name due to a marriage or other reason, SNC's Shareholder Department should be notified in writing to update the information and include a copy of the relevant legal documentation such as an ID card, marriage certificate, divorce decree, adoption decree, etc. authorizing the change.

It is also important to update an address after a move. Failing to update an address with the Shareholder Department could result in missing out on important information because shareholder addresses are used for mailing Venture newsletters, annual meeting election mailings, distribution checks, data-gathering documents for stock transfers and other important SNC materials and information. Much of the information SNC mails to shareholders describes opportunities and benefits for shareholders. If an address is not correct, a shareholder may miss information that could benefit themselves or their family.

### DIRECT DEPOSIT

Signing up is quick and easy – just complete the form inserted in this Venture, cut it out and return it to the Shareholder Department. Trust Beneficiaries (shareholders) can also update their direct deposit info on the MySitnasuak Shareholder Portal. Direct deposit is optional and paper checks are the default payment method. Please note that the bank account for direct deposit must be in the name of the Trust Beneficiary (shareholder) receiving the distribution, unless there is a custodian on file. If the names do not match, a paper check will be issued. Also, please note that if you are with a credit union (CU1, Global Credit Union, etc.) you must use your full account number, not your member number or deposits may not go through. 
