1.	I will follow and comply with the Sitnasuak Native Corporation Land Use Policy and Homesite Lease Agreement. I will maintain the lot, including all personal property, equipment, and improvements, and ensure the homesite is in appropriate condition throughout the term of the lease.
2.	I will bear all costs of any survey, recording of survey, placement of gravel, culverts, markers, and similar requirements. I will schedule a site visit with the SNC Land Committee to mark homesite boundaries if my Homesite Lease is approved.
3.	I will obtain, provide a copy to the SNC Land Department, and pay all federal, state, and local permits and fees (such as US Army Corps of Engineers, Alaska Department of Transportation, Alaska Department of Environmental Conservation, Alaska Department of Natural Resources, City of Nome) for wetland permits, right-of-way permits, waste treatment permits and water permits.
4.	I agree to submit plans to the SNC Land Department specifying any improvement plans that differ from this application and shall not construct any housing or make any other improvements or modifications of any kind to the lot without the written consent for Sitnasuak Native Corporation.
5.	I understand per the SNC Land Use Policy that if I do not have a stable structure placed on my Homesite within 5 years, my lease will be terminated, and the site will be opened to other applicants.
6.	I understand that I will have 30 days to execute my Homesite Lease after I get confirmation of approval by the SNC Land Committee and pay all fees prior to occupancy.
